We lack sufficient contact information to give written or telephonic notice. We are planning to provide substitute notice via e-mail (where e-mail addresses are available), conspicuous posting on our website, and publication to media available on a statewide basis.

As detailed in the attached notice to potentially affected individuals, on September 28, 2006, we were the victim of a break-in at our offices resulting in the theft of various computers. These computers contained information relating as many as 300,000 individuals, primarily our customers and also a small number of current and former employees and consultants in Nevada. The information on the computers relating to customers varied from one individual to the next, but may have included one or more of the following: name, postal address, e-mail address, and credit card information including credit card number. In most instances the credit card numbers were encrypted.

We are fully cooperating with the Las Vegas Police Department in its investigation of the theft. To date, we have received no information, from the police or any other source, indicating that the information about any of the potentially affected individuals has been used for any improper purpose.
