On November 2, 2006 at approximately 5:00 p.m., the Fall 2006 Lehman College Graduation List was published on the Lehman College website under the Senate documents section. This list contained the names of the graduating class and major, as it should, but also contained personal information such as social security number, address, home phone number, and date of birth. This was a serious error and the file was removed from public access as soon as the appropriate individuals at the College were notified. The file was available for approximately 17 hours.

There is no reason to believe that any individuals outside of the college community viewed the file, especially since the document was difficult to find on the website. However, since the document was observable by any individual using the worldwide web, we wanted to alert you to the possibility that your personal information could have been accessed. The national credit bureaus have programs to protect identity fraud and you may wish to contact them for added security. The contact information for the three major credit bureaus appears below.

Be assured that this case has been carefully investigated and appropriate measures have been taken to ensure this does not occur again.
