## A Letter from Rick Stephens, Senior Vice President Boeing Human Resources

I am writing to let you know that a Boeing laptop was stolen from an employee the first week of April 2006. In reviewing backed up data on the laptop, we discovered an old unencrypted file containing information on former Hughes Space and Communications and Boeing employees. You are receiving this letter because some of your personal information is in the file. There was no banking or credit card information in the file. However, your name, Social Security Number, and in some cases home address and phone number was included.

There is no evidence at this time that any information contained on the computer in question has been accessed, used or disclosed. Boeing sincerely apologizes for the inconvenience and frustration this may cause you.

### **What Boeing is Doing**

We are providing this notice to alert you to the possibility your personal information could be improperly accessed and to inform you of the actions you should take.

Boeing is partnering with ConsumerInfo.com, an Experian® company, provide a three-year Triple Advantage<sup>SM</sup> premium credit monitoring membership, at no cost, to individuals who may be impacted by this data loss.

### **What You Should Do**

We encourage you to sign up for your Triple Advantage<sup>SM</sup> Credit Monitoring membership as soon as you can. You must sign up yourself within 90 days of receiving this notice. Neither Boeing, nor anyone else, can do it for you.

**Re: Breach in the Security of Personal Information**

Dear Sir or Madam:

Pursuant to Section 899-a of the New York General Business Law (the "Security Breach Statute"), The Boeing Company hereby notifies you of a potential "breach of security of the system," as such term is defined in subsection 1(a) of the Security Breach Statute (the "Breach").

The enclosed notification of the Breach, sent by Boeing to affected individuals ("Notification"), contains information regarding the nature and circumstances of the Breach. The Breach affected approximately 3664 individuals, three of whom are New York residents.

Boeing intends this letter, including the enclosed Notification, to provide you with notice of the timing, content and distribution of the Notification as required by subsection 8(a) of the Security Breach Statute. Boeing is sending a materially similar letter to the New York Attorney General and the New York Office of Cyber Security and Critical Infrastructure Coordination.

If you believe that additional information is necessary for Boeing to meet its obligations under the Security Breach Statute, Boeing asks that you inform it of such.
