This notice is given to you as a courtesy. On June 28, 2008, our office at 2035 Ralph Avenue was burglarized while our office was closed. Among the items taken was a computer we believe may contain some of your personal information. We believe that your name, address, and social security number may have been exposed.

A report of the burglary was promptly made to the local law enforcement office, and the burglary continues to be investigated.
