Dear Valued Customer:

On May 16, 2008, we were advised that an external virus accessed our On-line Store and may have accessed the credit card information of certain customers. Upon learning of this unauthorized breach and attack, we immediately shut the site down. While the server on which the On-line Store resides was password protected and had appropriate firewalls and security protection, this virus may nonetheless have accessed your credit card information

We are actively investigating this incident to fully determine the extent to which credit card information of our customers may have been accessed, and wanted to alert you that your credit card information may be at risk. You should therefore consider taking the following steps:

- 1) notify your credit card company of the security issue and monitor your credit card account for suspicious activity
- 2) place a fraud alert on your account with the three national credit bureaus Equifax:(800) 525-6285; Experien (888) EXPERIEN; TransUnion: (800)-680-7289
- 3) obtain and review a free copy of your credit report. To order, visit annualcreditreport.com or call 1-877-322-8228.
- 4) visit the Federal Trade Commission's web site (www.ftc.gov) for additional information on how to protect yourself.
