Date the Security Breach was discovered:

We recently received notification from one of our vendors, CBIZ Benefits & Insurance Services, Inc. ("CBIZ"), that several computers were stolen from its offices in St. Louis, MO between December 24 and 26, 2007. CBIZ discovered the theft on December 26, 2007.

Estimated number of affected individuals: 35,455

Estimated number of NC residents affected: 2,282

CBIZ Benefits & Insurance Services, Inc.

Describe the circumstances surrounding the Security Breach and state whether the information breached was in electronic or paper format:

We provide recordkeeping services for retirement plans, such as 401(k) plans, and two of the stolen computers were used by CBIZ to prepare required federal filings for some of our retirement plan clients. As part of the filings, there are schedules that contain specific information on plan participants who left their respective companies during the 2005 plan year and certain participants who left in other years. Certain information about such former employees, including their names and Social Security numbers, are believed to be on the unencrypted hard drives of these two stolen computers. The data on such computers did not include addresses or dates of birth.

Regarding electronic information breached, state whether the information breached or potentially breached was password protected or encrypted in some manner. If so, please describe the security measures protecting the information:

The computers were password protected, but the hard drives were not encrypted.

Describe any measures taken to prevent a similar Security Breach from occurring in the future:

Although we review the data security practices of vendors that handle customer personal information, we are working with CBIZ and re-examining existing safeguards to determine whether any changes should be made. CBIZ has informed us that it is in the process of installing hard-disk encryption to all of its computers. Additionally, CBIZ promptly reported the theft to its local law enforcement authorities and is cooperating with them in the investigation of this matter.

Date affected NC residents were/will be notified: We are beginning to mail letters today.

If there has been any delay in notifying affected NC residents, describe the circumstances surrounding the delay pursuant to N.C.G.S. § 75-65(a) and (c):

CBIZ alerted us to the theft on December 31, 2007 and provided us with specific data as to the impacted plans and plan participants on January 4, 2008. As contemplated by N.C.G.S. § 75-65(a), some time has been needed to investigate and complete matters such as determining the scope of the breach and the data involved, communicating with impacted retirement plans, and coordinating the mailings to impacted plan participants.
